AGREEMENT

This agreement was made on the day and with the terms and conditions specified below, between **JátékMester Élményprogram (Brightly Kommunikációs Ügynökség Kft.)**, address: 50 Ilka street, Budapest 1143, (tax number: 12452648-2-13, phone number: (30) 639-3009), hereafter referred to as **Organizer**, and the **Parent**, or the legal representative of a child / children named on the Zoo Camp application form.

1., The parties to this agreement agree that the Organizer, in accordance with the agreement made with Fővárosi Állat-és Növénykert (Budapest Zoo & Botanical Garden) admits the child / children specified above to the ZOOTábor (ZOO Camp) during the time given. The prerequisites of admission are the following: payment of the camp fee should be made to the Organizer; the Parent's child / children should own a valid pass to the Budapest Zoo, and the Parent should accept the terms and conditions specified in this agreement. The Parent acknowledges that the camp does NOT provide sleeping opportunities for the child / children.

2., The parties to this agreement agree that the timetable of the camp is the following:

07:30 - 08:00.....	Arrival of children	The parties to this agreement agree that the Parent hands over the child, who should be dressed appropriately for the programmes of the camp, to the representative of the camp at the specified time, and collects the child at the time the programmes of the camp finish each day. If the Parent fails to collect the child until 17:00, the child will be looked after at Állatkert Játsszótér (Zoo Indoor Play Centre). The Parent has to pay the prevailing fees of this child care service on the spot upon collection of the child. The Parent acknowledges that the language of the camp is Hungarian (or English). The Organizer reserves the right to change the programme specified in the agreement (according to prevailing circumstances).

3., The parties to this agreement agree that the **Organizer** provides for 1 supervisor for each group of 10 children.

4., The **Parent** assumes the obligation to produce a health statement not older than 3 days, stating that the child is healthy and thus can take part in the programmes of the camp. The **Parent** acknowledges that the organizers of the camp do not admit children to the camp who need special individual care or non-stop supervision. If the **Parent** fails to inform the **Organizer** about such conditions in advance, the **Organizer** refuses to take any responsibility for possible consequences. **In the case of illness:** The parties to this agreement agree that if the child gets ill during the time of the camp, the parent has to let the representative of the camp know about this fact as soon as possible, and until the child gets completely healthy again, they must not be taken to the camp. If a camp supervisor notices signs of illness on a child, they have to let the **Parent** know about it as soon as possible, and the **Parent** has to collect the child from the camp. If the child has already started a camping session, days missed due to illness can be made up for for an additional fee of 3000 HUF / day. If the child CANNOT come to the camp due to illness and the Parent informs the organizers about this fact until Friday the week before the camping session commences, the **Organizer** allows the child to take part in the camp during a later camping session without any additional charges. In this case, we kindly ask you to produce a medical certificate of the illness.

5., The parties to this agreement agree that the **Organizer** takes full responsibility for the supervision of the child / children, excluding cases that do not belong to supervision (e.g.: clothes being torn, etc.) and cases when the child / children refuse to follow the instructions of the supervisor. The **Parent** accepts that the **Organizer** does not take responsibility for devices and valuables taken to the camp (e.g.: mobile phones, cameras, portable music players, etc.).

6., The parties to this agreement agree that both children and parents have to follow the house rules of the Budapest Zoo and the instructions given by the supervising teacher of a group.

7., The **Organizer** lets the **Parent** change their mind and cancel their application to the camp. according to the following rules mutually accepted by The parties to this agreement.

Terms and conditions of cancellation: If the Parent cancels the application at least 10 working days prior to the commencement of the chosen camping session, the Organizer gives a 50% refund of the camping fee. If the Parent cancels the application later than the above date, the camping fee is not refunded.

Terms and conditions of session modification: Camping sessions can be modified free of charge until 12:00 on Wednesday the week before the session commences. After this deadline an administrative fee of 5000 HUF is charged. The parties agree that cancellation and session modification can only be made in writing. If the camping programme does not take place at all, a full refund of the camping fee is granted to the **Parent**.

8., The parties to this agreement agree that the **Organizer** only considers this agreement to be valid if the **Parent** pays the camping fee to the **Organizer** in cash upon signing the agreement.

9., I hereby confirm with my signature that I have read, understood and accepted the terms and conditions of participation in Zoo Camp. I also give my explicit consent to the **Organiser** to use any photos or videos made at the camp for advertising purposes free of charge and with no limitations.
