

## **Data Management Policy**

The present Data Management Policy provides information about the management of the personal data given to Játékmester Gyerekprogram Korlátolt Felelősségű Társaság (based at: 1214 Budapest, Mag utca 3.; company registration number: 01-09-181981; data protection registry number: NAIH-112165/2017., hereafter referred to as: **Data Manager**).

### 1. The range of involvement

You and the minor You represent are involved, provided that you register into the database operated by the Data Manager either on the website operated by the Data Manager, or in writing, i.e. on a form issued by the Data Manager, or in any other way. Furthermore, You are also involved if you use the Data Manager's services or express your wish to do so by answering any of the Data Manager's offers or if You give your personal data to the Data Manager in any other way.

### 2. The range of managed personal data

The Data Manager can manage the following personal data:

- The name,
- the address,
- the e-mail address,
- and the telephone number

of the representative of the minor who applied for the event organized by the Data Manager; and

- the name,
- the date and place of birth,
- the address,
- the sex,
- and the mother's name

of the minor who applied for the event organized by the Data Manager.

The Data Manager also records the fact whether the minor who takes part in the event organized by the Data Manager is in an appropriate health condition to take part in the event. The Data Manager also records the fact whether the minor who takes part in the event organized by the Data Manager has any allergies.

### 3. The aims of data management, legal basis, data transfer

The Data Manager collects and manages the personal data specified above for the following aims:

a, identifying You and the minor You represent;

b, registering You and the minor you represent for the events organized by the Data Manager if you have applied for them;

c, keeping in touch with You regarding the participation in the events organized by the Data Manager;

d, informing You about the services provided by the Data Manager and about the possibilities of using them;

e, sending You newsletters including special offers and competitions organized by the Data Manager and their business partners.

#### 4. Data collection

The Data Manager manages data collected from the following sources:

- the personal data You provide;
- the personal data You provide to third parties, given that you have consented to their transfer.

#### 5. The duration of data management

Except for cases bound by the law, You can request the deletion of your personal data. If you do so, the Data Manager will delete your data within 3 working days from the receipt of your request. Provided that You consented to data management, the Data Manager can manage your data even after the withdrawal of your consent in order to comply with laws that the Data Manager is bound by, or in order to enforce the lawful interests of a third party (given that this interest is proportional to the laws regarding the protection of personal data).

In the cases of data management bound by the law, the Data Manager manages the data for the duration prescribed by the law.

If there is a civil law relationship between You and the Data Manager, the regulations of civil law also apply to the management of data. In this case, personal data can also be managed in order to enforce civil law interests. If, as a consequence of Your illicit deeds, public or legal proceedings are taken, the Data Manager can manage your data in order to help those proceedings come to a close.

Based on the above, the Data Manager will delete Your data if:

- the management of the data is illegal or the Data Manager is bound by law to delete them;
- You request the data to be deleted;
- the data is incomplete, false and thus it cannot be used;
- the aim of data management does not exist any more;
- the authorities or the court orders them to be deleted.

As a result of data deletion Your personal data and the data of the minor who You represent will be made unrecognizable in a way that the data and You or the minor who You represent cannot be identified any longer.

## 6. Access to personal data

Your data and the data of the minor who You represent can be accessed by the staff of the Data Manager whose duty it is to contribute to the aims of data management. The representatives of the Data Manager's clients may also have access to Your data if you explicitly consent to your data being transferred to them.

The data manager may forward your data to service providers (especially IT service providers) for data processing related to the aims specified above.

The Data Manager's data processor is MEDIACENTER HUNGARY Informatikai, Szolgáltató és Üzemeltető Korlátolt Felelősségű Társaság (based at: 6000 Kecskemét, Sosztakovics utca 3., II. emelet 6.; company registration number: 03-09-114492; tax number: 13922546-2-03).

## 7. Law enforcement opportunities

According to the conditions of Act CXII of 2011 on Information Self Determination and Freedom of Information you may (i) request information from the Data Manager about the management of personal data; (ii) ask the Data Manager to amend, erase or block access to personal data; (iii) protest about data management and (iv) in cases of violation of rights turn to the Hungarian National Authority for Data Protection and Freedom of Information (address: 1125 Budapest, Szilágyi Erzsébet fasor 22/C.; telephone number: +36-1+391-1400; fax number: +36-1-391-1410; e-mail: [ugyfelszolgalat@naih.hu](mailto:ugyfelszolgalat@naih.hu)) or to the court. Find the rights and the options for law enforcement regarding data management in subsections 13-17 and 30 of Act CXII of 2011.

## 8. Data protection

The data manager ensures the security of Personal data, and has taken all technical and organizational measures and established the rules of procedure necessary to enforce Act CXII of 2011 and other rules and regulations regarding the protection of personal data.

## 9. Modification of the Data Management Policy

The Data Manager reserves the right to modify the present Data Management Policy. Before any modification is made You will be informed by post or by email and at the same time a notice along with the current version of the Policy will be posted on our website. You will be sent all the relevant information about the modification in time so that you can protest about further management of your personal data and you may also request your personal data to be deleted.
